BOR_FN_PAY_CHECK_REGISTER	Navigator > Reporting Tools > Query > Query Manager/Viewer
	Uses pay check record to pull gross to net and check mailing address for anyone in a pay run receiving a paper check (i.e., does not have direct deposit). Allows payroll to look for checks with international addresses. Prompts on Pay Run ID and Department SetID.
BOR_FN_TREATY_NRA_TBL	Navigator > Reporting Tools > Query > Query Manager/Viewer
	Allows for audit of PeopleSoft tax treaty tables up-to-date and correct.
BOR_FN_GLACIER_1042S_VISA	Navigator > Reporting Tools > Query > Query Manager/Viewer
	Pulls all EEs with 1042S tax treaty data with PII and visa data for reconciling with GLACIER. Same as BOR_FN GLACIER_1042S_DATA, but also includes visa data. Prompts on Company, Calendar Year and Badge Type, all required.
BOR_FN_NRA_W_FICA	Navigator > Reporting Tools > Query > Query Manager/Viewer
	Returns any employee with Special Federal Tax Withholding Status = Non-Resident Alien if FICA status on job data does not equal Exempt. An employee returned on this report requires validation of FICA status from GLACIER.
